B.A./B.Sc. (4-year Honours & Honours with Research) - CSR/45/2023, dt.18.12.2023

Clause no.22 (iii) & (iv) are amended as follows: -

A candidate clearing all the papers of the 1st to 6th semesters and also completing a 3 credit

Internship, and exiting the course at the end of the 3rd year shall get.

Three-year B.A./B.Sc. Degree with Single Major in (.....Subject.....), as the case may be.

Three-year B.A./B.Sc. Degree with two Cores (.....Subjects.....) and one Minor

B.Com. (4-year Honours & Honours with Research and 3-year)- CSR/46/2023, dt.18.12.2023

Clause no.23(iii) & (iv) are amended as follows: -

A Candidate pursuing 4-year B.Com. Course clearing all the papers of the 1st to 6th semesters and also completing a 3- credit Internship and exiting the course at the end of the 3rd year shall get a Degree as-

Three-year B. Com.Degree with Single Major (In Accounting & Finance).

- A candidate pursuing 3-year B.Com. course clearing all the papers of the 1st to 6th semesters and also completing a 3 credit Internship, at the end of the 3rd year shall get a Degree as-

Three-year B.Com. with one Core (Accounting & Finance) and one Minor (Marketing / E-Business)

❖ Amendments of Nomenclature of Degree, as published in the Examination Regulations of

B.A./B.Sc./B.Com. (4-year Honours with a Core Vocational subject)- CSR/44/2023, dt.18.12.2023.

Clause no. 20(iii) is amended as follows: -

A candidate clearing all the papers of the 1st to 6th semesters and also completing a 3 credit Internship, and exiting the course at the end of the 3rd year shall get


Three-year B.A./B.Sc./B.Com. Degree with a Core Vocational subject (.....subject.....) as the case may be.

The above shall take effect for B.A./B.Sc./B.Com. Courses of Studies under CCF, 2022, which was introduced from the academic session 2023-2024 and onwards.
